


Bill and Margaret's sparkling day



From the Chief Executive

Claycot Park is 30

One of the most rewarding aspects of my role is getting out to visit you in your homes. As you can imagine, I was delighted to be invited to the 30th anniversary party of Claycot Park in Edinburgh.

As is often the case, the residents' committee and staff went the extra mile to ensure its success and to make everyone very welcome. I'm very grateful that the residents wanted me and my fellow staff to come along.

For my welcome speeches, I like to research a development. I'm always intrigued by the area's history and the people that have lived there, including the notable Hanover residents.

We manage nearly 200 developments across Scotland and, whilst I know a fair amount about them all I can't pretend I don't need to do my research on their histories – and yes, Claycot Park and its surroundings have a wonderful history! I'd like to share some of this with you.

I found out it was named after Claycott Farm (yes, it had two 't's in those days!), thought to have been due to the heavy clay soil – not unusual for Scotland. The original farm house is now part of the housing development.

The Edinburgh suburb of Corstorphine was a rural village until as recently as 1939, when it became part of Edinburgh. Now best known for Edinburgh Zoo it's also had its fair share of distinguished visitors in the past, like Oliver Cromwell and Bonnie Prince Charlie.

One of the area's best stories involves a lovers' tiff – with shades of Lady MacBeth.

The Laird of Corstorphine Castle in the 17th century was James Forrester, a popular man – but also fond of ladies and drinking!

He'd arranged to meet his lover – Lady Nimmo – at the dovecot (just around the corner from Claycot Park) late one night. She was his niece as well as his lover, so they wanted to keep the relationship a secret! Lady Nimmo waited a while and, guessing he was in a local hostelry, sent her servant to find him.



He eventually turned up drunk, and she was so angry she killed him with his own sword. She was executed in 1679 for murder. At her execution she wore a white hooded gown and, to this day, her ghost is said to haunt the dovecot and surrounding areas. She must have been a strong woman!

There are many wonderful stories throughout history, but for me it's the 'real histories' of our residents that I find much more interesting. You're the most important thing to Hanover and I was so pleased to find out how happy Claycot Park residents are. I heard lots of positive reports – from how "Claycot Park is the bees' knees" to how happy you are with Hanover.

I also heard some hilarious stories. Stories of one strong-willed, 100 year old – Doctor Jenny – who only accepted visitors if they gave her a bag of Devon Toffees. Another resident – who shall remain nameless – was never out of high heels. Everyone knew she was coming because of the noise they made in corridors!

These stories were kindly passed onto me by two residents who've lived at Claycot Park for more than 20 years – Margaret Robertson and Meg Turpin. Unfortunately Margaret wasn't well so couldn't join us at the party – but, in the familiar and friendly Hanover manner that we're all well aware of, it was ensured that a piece of cake (cut by Meg) was duly delivered to her flat.

A new name for sheltered housing?

We're launching a new housing service and we're looking for you to name it!

About to be launched at nine developments in Glasgow, the service has come about after negotiations with the council following funding changes.

It will keep all the key elements of sheltered housing that you value – including your morning call – but the need for a six monthly housing support plan review will be removed. It will also mean development managers can raise repairs works orders themselves. Contractors will be notified of maintenance work more quickly and the manager's local knowledge will improve our ability to achieve a 'first time fix' for residents.

In future, we may extend the service to other areas, though only after we've consulted with the residents affected and local authorities.

We need to think about what may appeal to residents in the future and we want you to think of a new name for the service. Perhaps we should move away from the term 'Sheltered Housing', as some feel it no longer reflects what we do, or is inappropriate (especially from those residents who feel fitter). Or, you may like the term. Some providers call their service 'Retirement Housing'. Whatever you think, send us your ideas! The name we choose for the service may also mean a change in job title of the development manager too.

To encourage as many ideas as possible we'll put ALL entries into



a draw to win a $\pounds 50$ voucher – whether we choose the name or not. Send all entries via email or post using the details on the inside back cover by 1 September, and we'll announce the winner in the Christmas edition of Hanover Today. We'll present a selection of the ideas to Hanover's Board in September, when a final name will be chosen.

Get your thinking caps on!

Did you spend time in care as a child?

If so, a new organisation aimed at increasing the understanding of what happened to children in care in the past with a view to improving the system in the future would like to hear from you.

The National Confidential Forum (NCF) wants people who spent time in institutional care to come forward and share their experiences in a safe, nonjudgemental setting.

NCF Project Manager Ben Lukins said "Sharing experiences can be therapeutic and, importantly, the information given by participants will contribute to making positive changes to children in care today and the future.



"By taking part in the Forum, participants will enable us to build a picture of the legacy of institutional care in Scotland, which will form part of a national record."

Partnership working in the Borders

We're delighted to announce a new partnership with Scottish Borders Council to provide a 'housing with care' service in three housing developments.

Residents of Glenfield Court in Galashiels, Mercer Court in Innerleithen and Queens Court in Jedburgh can now benefit from personal care directly from Hanover's own care staff. Around 20 staff have been employed to deliver the service, which provides real benefits to residents. We spoke to Diane MacDonald, the service's co-ordinator.

"The main advantage is the extra flexibility", she told us.

"If someone wants to have their tea a bit later, or stay in bed longer, the staff can come at a different time as they're very close by and not under the same pressures as visiting homecare staff. It also means residents can leave hospital more quickly as our team are on site and can spring into action at short notice. "We've received great feedback from residents and their families. It provides people with a feeling of security as they become familiar with regular staff."

Hanover currently delivers a similar service at very sheltered developments in Elgin and Dalry, but this is a first for Hanover's sheltered housing.

What's your background?

I left university with a Geography degree and no idea what I wanted to do! I read an article by a housing officer and liked the idea of helping people, involving property and not being desk bound.


Latterly I joined the Scottish Tribunal Service, sitting on housing panels considering disputes between owners & factors and tenants & landlords, before joining Hanover where I hope the organisation can use my knowledge and experience of more than 30 years in the sector.

What do you enjoy most about being on the Board?

I'm not sure enjoyment is the right word! It's sometimes with a sinking heart that I carefully read the large wad of papers before meetings. However, it's good to feel you've added value to a decision-making process and helped to maintain and improve what we do.

I enjoy working with and learning from other Board members and staff, and love meeting staff and residents to find out how we are doing as an employer and provider.

Knowing what customers want – and how good we are – is important to me. Developing how we respond



to customers and understanding what we are good (and not so good) at from listening to residents is something that I want to champion.

What do you see impacting on Hanover in the future?

There are opportunities to develop a range of services for older people and, from research and piloting services like care at home, this seems to be welcomed by residents.

We need to develop these against a backdrop of funding issues and different approaches from local authorities across Scotland. But we also need to ensure our main focus of business – sheltered housing – remains viable for residents. It's a real challenge but so important to deliver on.

What do you like to do when not working?

Part of the reason for semi-retiring was to enjoy hill walking. I love this, as well as easy rock and ice climbing and skiing. They take up significant time while requiring a good level of fitness so I also spend time in the gym, on the bike or running. It seems sensible to enjoy it while my body's able to!



Money matters



The importance of making a will

What is a will?

A will lets you decide what happens to your money, property and possessions after you die. You can write a will yourself, however you should get legal advice to make sure the will is interpreted in the way that you want it to be. You also need to get your will formally witnessed and signed to make it legally valid.

To update a will, you need to make a formal alteration to it (called a 'codicil'), or make a new will.

Writing a will

Your will should include:

- who you want to benefit from the will;
- who should look after any children under 18;
- who will sort out your estate and carry out your wishes after you die (this is called your 'executor'); and
- what happens if the people you want to benefit die before you.

Getting legal advice

It is always a good idea to seek legal advice:

- to make sure the will has the effect you want;
- **b** to ensure there are no mistakes within the will; and
- if you are unsure about how to make a will.

There are many solicitors who specialise in this area of law. It is also vital you seek legal advice if your will isn't straightforward, for example if you:

- share a property with someone who isn't your spouse or civil partner;
- want to leave money or property to someone who can't care for themselves;
- have several family members who may make a claim on your will, for example a second spouse or children from another marriage;
- have a permanent home outside the UK;
- have property overseas; or
- have your own business.

For more information on wills, you should contact a solicitor. To find a suitable solicitor, contact the Law Society of Scotland (**www.lawscot.org.uk** or **0131 226 7411**) or your local Citizens' Advice Bureau (**www.cas.org.uk** or check the phone book for your nearest branch).


