Would you like to become a member of Hanover?



Members of Hanover are invited to the Annual General Meeting (AGM) of the organisation in September each year. Members have the opportunity to review the Annual Report and Financial Statements and to elect / re-elect members to sit on our Board.

Hanover's Board is made up of volunteers who are committed to ensuring that the organisation is run efficiently; that high quality services are provided to our customers; and that the organisation is in good financial health and meets all regulatory and legal requirements. Only members of Hanover can be elected to the Board.

Members can stand for election to the Board, provided they can demonstrate that they have relevant skills, knowledge, or experience to take on the responsibilities of being a Board member. All recruitment to our Board is carried out in line with our Board Recruitment and Succession Policy.

Who can apply to be a member?

We are committed to developing a broad and diverse membership that reflects and supports the work that we do and the communities that we serve.

The following people can apply for membership with Hanover Scotland:

- Customers of Hanover Scotland. Each member of a household can apply to be a member separately, however only one person per household can stand for Board membership;
- People who have an interest in our work; or
- Organisations which support our work.

Applicants must be aged sixteen or over. Employees of Hanover are not permitted to be members.



What do members do?

As a member of Hanover, you will be able to:

- Attend the AGM and receive the annual report and annual financial statements;
- Attend and vote at other general meetings;
- From time to time, be consulted about specific plans or proposals that the Board is considering.

Members Register and Data Protection

We maintain a register of members in accordance with our <u>Rules</u>. Anyone may inspect our summary membership register which shows the names of all shareholding members who have given consent, but not the addresses or any other personal information of members in accordance with our Data Protection Policy.

Ending your membership

Members can resign at any time by writing to the Secretary at the contact details provided.

How can I become a member?

Becoming a member is easy. Simply complete the membership application form on the next page (or via our online form) and submit it to the Company Secretary along with a one-off payment of £1 to cover your membership share fee.

Completed applications must be submitted to the Secretary and can be sent to us via our online application, email or post. We would prefer that your application is emailed to us or completed via the online application.
