# Forty and fabulous

2019 is a special year for Hanover (Scotland) because we are turning 40. We might not look a day over 21, but we have been housing and supporting people in Scotland for four decades.

1979 was a momentous year in many ways; the UK got its first female prime minister, a devolution referendum was held in Scotland, the price of milk increased to 15p a pint and Hanover (Scotland) Housing Association Ltd came into being at premises on Albany Street in Edinburgh.

At that time, the newly established Association took on management of seven developments which were already in place in Scotland, having been established by the parent organisation Hanover Housing Association. Within the first year of its existence, Hanover (Scotland) established three new developments, one in Aberdeen, one in Glasgow and one in Edinburgh.

The original objectives of Hanover (Scotland) were:

"The provision of housing and any associated amenities for people in necessitous circumstances upon terms appropriate to their needs.

The provision of housing and any associated amenities specially designed or adapted to meet the needs and disabilities of the aged."

Today, Hanover (Scotland) manages 205 development across 24 local authority areas in Scotland. We have around 7,000 residents in roughly 5,500 dwellings. Hanover Telecare takes 1.5 million calls a year and offers support to around 40,000 people across the country.

Our objectives have evolved too. Today, our Purpose is:

To help older people feel safe and secure at home and to live fulfilling and independent lives.

While our official 40th birthday falls in April 2019, we intend to make the best of the opportunity to celebrate Hanover, its staff and residents throughout the year.

# Community spirit leads to a makeover

Residents at **Hanover Court** in **Inverturie** are celebrating after their garden received a makeover following a £10,000 lottery grant and help from people in the local community.

Tenants at Hanover Court were originally inspired to revitalise the development's garden after a visit in November 2016 to another Hanover development, Burnside Court in Buckpool, where tenants had transformed their garden with the help of a lottery grant. Many meetings were then held between Hanover Court's Sheltered Housing Manager Cathy Paul and the Residents' Committee as they discussed their shared vision for their own garden.

Hanover Court tenant **George Taylor** was in contact with Mike Barron, an Inverurie Rotarian, who he asked for advice on developing the project and applying for funding from the National Lottery's Awards for All (Scotland) in order to make the project happen. Mike was only too happy to be involved and thanks to his help the project, which aimed to improve the quality of life for tenants by upgrading the internal activities and providing improved outside facilities at Hanover Court, received an Awards for All (Scotland) grant of £10,000.

The whole project was truly a team effort. In addition to Cathy, Mike and the tenants, also involved in planning and implementation were Hanover (Scotland) Operations Manager, Dougie McPhee, and two other Inverurie



Rotarians, Jim McColl the BBC Beechgrove Garden TV stalwart, and Eric Massie. A team of six from the Inverurie Men's Shed carried out work on the garden while much needed hospitality was provided throughout the project by Hanover Court tenants, Kathleen Downie, Nan Hosie and Eileen Donald.

## Step Count Challenge 2019

This year's Spring Step Count Challenge kicks off on 29 April 2019. For those of you who are new to it, the challenge is an eight week walking event with a simple aim: walk more and feel the difference. Walking has lots of health benefits and active people live longer and healthier lives. Furthermore, walking is both easy and free.

Taking part is easy. You enter as part of a team of five people and teams can be made up of residents, staff or a mixture. You record your steps with us and we keep track of everyone's progress throughout the eight weeks.

Counting your steps is easy. You can use a pedometer that clips onto you clothing, an activity tracker such as a Fitbit or even your smart phone. Hanover is providing pedometers for everyone who registers for the challenge.

## Add your voice

Scottish Housing Regulator
National Panel

Would you like to help improve social landlord services in Scotland? The National Panel is one of the ways that the Scottish Housing Regulator can hear from people who use social landlord services and they are looking for new members.

Panel feedback is essential to make sure the Regulator focuses on the important things. The Regulator already has more than 400 people having their say. Members receive occasional surveys, information updates and take part in other feedback exercises. Participation is always optional.

The Panel is open to anyone who uses social landlord services. Members include social tenants, people who have been homeless, home owners who receive factoring or common repairs from a social landlord, and people on social rented Gypsy/Traveller sites.

## PAT testing

Portable Appliance Testing is an essential task that must be carried out in order to ensure the safety of electrical appliances, such as lamps, in the communal areas of developments. Getting these appliances tested can reduce the risk of electrocution or even a fire. The PAT test inspection checks the plug, fuse, wiring, flex and appliance to ensure it is safe to use.

Whilst testing takes place as a matter of course on our rented developments, we are keen to see that all of our owner occupied developments also take part.


# Happy Birthdays

### **Money Matters**

## Beat the scammers

At our tenants' conference in August, we featured a very successful workshop run by staff from the Royal Bank of Scotland on how to spot scams.

At Hanover Scotland, we regularly hear from residents about scam attempts that they have encountered. We don't want to make people fearful, we want you to have the tools to recognise and tackle the scammers, and to support your family and friends to do so as well.

Derek Mitchell, chief executive of Citizens Advice Scotland, told us: "We are urging people to be vigilant and follow our tips on how to spot and avoid scams. The main thing is to be very cautious about any apparent bargain. Remember, if it looks too good to be true, it probably is."



Chief Executive of the charity Age Scotland, Brian Sloan, said: "If you report a scam or attempted fraud, you can help protect others in your community. It helps police and fraud protection organisations become more responsive to current trends and raise public awareness of these crimes."

Here are some tips on how to avoid becoming a victim:

- Be wary of all tradespeople on your doorstep and thoroughly check their ID.
   Genuine traders won't mind you being sceptical.
- Be cautious with unexpected phone calls, letters or emails. Don't let them pressurise or rush you.
- If you are unsure about an apparent bargain, tell them you'd like time to think about it, then do some research: look for the company online or ask friends and family what they think.
- Remember you can get free advice on scams from your local Citizens Advice Bureau or by calling the consumer helpline on 03454 040506.
- If you find a scam, report it to the police or trading standards – and tell your family, friends and neighbours.

One scam that appears to be on the increase is malicious calls, voicemails, text messages or emails to members of the public purporting to be from HMRC.

Listen to your instincts. Don't be rushed or pressured into making a decision. Under no circumstances would a genuine bank or some other trusted organisation force you to make a financial transaction on the spot.

# Development Walkabouts for tenants

One of the options for customers to get involved with Hanover is to volunteer for 'Development Walkabouts'. This is a process by which volunteer tenants take time out twice a year to do 'walkabouts' of their developments, with staff, in order to give their views on any communal repairs which have been undertaken, report any new repairs that are needed, examine the standard of landscaping and make recommendations for any improvements needed. Tenants will report their findings to their Housiing Officer and/ or Maintenance Officer and the Housing Officer will then feedback the outcomes of the report and any completed or planned work to residents on the development.

## 40 years of Hanover


